**Accepted Artwork**: McCloud Nature Center is dedicated to the enjoyment of nature for visitors of all ages. Artwork focused on the natural world is greatly appreciated. Hendricks County Parks and Recreation and McCloud Nature Center are accepting artists' original work including (but not limited to): acrylic and oil paintings, watercolors, drawings, photography, fibers, ceramics and sculptures. The staff reserves the right to refuse artwork based on inappropriate content, and will have the absolute right to make the final decision. Please provide a list of the artwork with descriptions, and include a photo of the artwork.

**Duration of Display**: The exhibit will be on display in McCloud Nature Center from the first Friday of the month to the last Saturday of the same month. We request that artwork is put up during regular business hours Tuesday through Thursday prior to the first Friday of the month. Exhibits must be taken down on the Tuesday or Wednesday following the last Saturday of the month. Please schedule these times with McCloud staff.

Conditions and Restrictions: It is the responsibility of the artist(s) to ensure that all two-dimensional art pieces do not exceed 12 square feet and are framed and ready to hang. We ask that all three-dimensional pieces do not exceed 12" deep. McCloud Nature Center has limited display case space for fragile artwork, but we recommend the artist(s) provides some form of display case or protection for small items. All works should not weigh more than 40 lbs.

**Labeling for Display**: Please include a typed tag 2" by 3 ½" for each piece on display that includes the artist's name, title of the piece, media used, and sale price (if applicable).

**Publicity:** McCloud Nature Center will list and describe exhibits at the center in program publications, on our website, and through public notices. Staff will also regularly publish press releases to inform the public about upcoming exhibits. Any additional publicity is the responsibility of the artist.

**Sales:** It is the responsibility of the artist to determine the sales price, if any, for each piece of artwork and the artist will handle any sales. If the artist wishes to make a donation of the sales, the artist will state a flat amount or percentage of the sale that they will make to the Parks Foundation of Hendricks County in their biography.

**Liability Waiver**: Artists shall hold harmless the McCloud Nature Center from any and all claims or liability arising from or connected with McCloud Nature Center, including without limitation, any damage or injury to person or property.

Artist does hereby release McCloud Nature Center from all liability from any accident, damage or injury caused to person or property of the Artist whether or not caused by McCloud Nature Center or its agents.
